Rules and Regulations

- All stands strictly accommodate a maximum of six (6) persons. This includes adults, children and toddlers of all ages.
- The Luxury Tent strictly accommodates a maximum of two (2) persons. This includes adults, children and toddlers of all ages.
- Only one (1) caravan / motor home and one (1) tent are allowed per stand. A maximum of two vehicles are allowed per stand.
- No occupant will be allowed on the premises without a proper caravan / motor home or tent. No refunds will be provided.
- A maximum of four (4) day visitors, travelling in one vehicle are allowed, per day, per stand at an additional cost of R70-00.
- The Monateng Caravan Park is open to day visitors between 08:00 – 22:00. All day visitors are required to vacate the property by no later than 22:00.
- Monateng Caravan Park check in time is from 08:00 on date of arrival and check out time is strictly by 15:30 on the date of departure.
- In order for us to maintain the high standards that you have come to expect of the Monateng Caravan Park, it is imperative that you strictly adhere to the check out time.
- A Key / Breakage Deposit of R350-00 is required upon check in. This deposit is refundable if the site / unit is left in a pristine condition upon check out.
- A fine of R350-00 (per stand) will be deducted from your Key / Breakage Deposit should you leave the site / unit excessively dirty.
- Occupants of the Monateng Caravan Park are obliged to keep the accommodation in a clean, tidy and hygienic condition.

- All occupants and day visitors are requested to use all resort facilities and treat all property on the Resort in such a manner that will not cause damage. Occupants and day visitors are subject to Monateng Safari Lodge Management Regulations with regards thereto.
 - Any occupants and / or day visitors damaging any part of the accommodation, movables or facilities on the Resort; whether willfully, negligently or accidentally, shall be held liable for the cost of repair.
 - Occupants are bound by Management Regulations to take inventory in respect of the contents of the Luxury Sites / Luxury Tent at the commencement and conclusion of their visit. Please note that occupants are held responsible for the contents of the unit / tent.
 - The cost of any missing or broken items will be deducted from the Key / Breakage Deposit upon departure. For matching purposes, Management reserves the right to replace missing or broken items and occupants are therefore requested to refrain from replacing any breakages.
 - All personal property brought onto the property belonging to Monateng Safari Lodge or the Monateng Caravan Park, is done so at the sole risk of the occupant or day visitor. The occupant or day visitor will have no claim whatsoever for any loss suffered, however arising.
 - Occupants and day visitors are requested to refrain from removing any appliances from the Luxury Sites / Luxury Tent at the Monateng Caravan Park.
 - Please allow your neighbours to enjoy the tranquility of the Resort. No loud music or foul language will be tolerated.
 - Occupants and day visitors are requested to wear appropriate swimwear when making use of the swimming pool.
 - No alcohol is allowed near the swimming pool area. Any drunk / disorderly behaviour will lead to eviction from the property. Any / all disciplinary decisions made by Monateng Caravan Park Management will be final.
 - No firearms are allowed at the Monateng Caravan Park. Facilities for safekeeping are available at Reception, upon request. No hunting is allowed on any property belonging to Monateng Safari Lodge or the Monateng Caravan Park. The use of firearms of any type, catapults, crossbows, throwing knives, etc. is strictly prohibited. The setting of snares or traps of any kind will also be considered a serious contravention of this rule.

- Please do not collect or remove any wood from the Nature Reserve. Firewood and charcoal is available from the Monateng Kiosk, located at the Lodge.
 - No fires are allowed to be lit outside of the demarcated areas.
 - No pets are allowed on the Resort. This ensures the safety of birds and small wildlife in the area.
 - No littering will be tolerated. Please help us keep the resort clean.
 - Occupants and day visitors are reminded that any gates and fences encountered during the course of walks or game drives mark the boundaries of the resort. Please keep in mind that the property beyond these gates / fences is strictly off limits.
 - The speed limit throughout the entire Resort is strictly 25 km per hour. Occupants and day visitors found to be in contravention of this rule will be fined R200-00.
 - No motorcycles, quad-bikes or tri-bikes are allowed.
 - Occupants and day visitors are requested to refrain from cycling on the grass at the Lodge area.
 - **Strictly no private vehicles are allowed on the Game Farm. Occupants and day visitors will be fined R500-00 per vehicle if this rule is contravened.**
